About the Facility:

Your DUI event ticket entitles you to participate in all aspects of the demos, and enjoy a barbecue lunch. Advance Ticket holders for the Demo Day will receive a special discount park admission of \$10, courtesy of Windy Point Park.

All activities will begin at 9am on Saturday. We will be diving the cool, clear waters of Lake Travis. There is easy access from the parking area. Bring all of the equipment you'd need for a normal dive. Air fills are available on site. We recommend arranging any SCUBA equipment rentals you may need with your local dive shop in advance, to be sure you are fully equipped.

About the Event:

Prior to the demo, each diver will be fitted with the appropriate drysuit and accessory DUI equipment. Once you are dressed and ready to dive, you will check in with the dive-master in charge who will assign you an instructor or divemaster as a guide. As soon as there are 2-3 people ready to go in the water, an experienced divemaster or instructor will escort you on your dive. You can do as many test dives as you wish. Divers that are already drysuit certified are welcome to plan their own dives accordingly, within the limits of their current experience. With more than 110 suits of various sizes there usually is little wait. If you'd like to test dive a specific model of suit, please let the staff know so that they can do their best to make one available for you.
